

ST. ALOYSIUS GONZAGA (1955)

(Modifications incorporated by decree dated May 1, 1996, printed in *italics*.)

Beginning on the center line of the Mississippi River and the East Baton Rouge-West Baton Rouge civil parish line at point on a line drawn due west from the intersection of Brightside Drive and River Road, to the east along this line and the center line of Brightside Drive until its intersection with Nicholson Drive; thence to the north along the center line of Nicholson Drive until its intersection with Gourrier Avenue; thence east along the center line of Gourrier Avenue until it intersects Burbank Drive; thence to the southeast along the center line of Burbank Drive until its intersection with West Parker Boulevard; thence to the northeast along the center line of West Parker Boulevard until its intersection with Highland Road; thence to the southeast along the center line of Highland Road until its intersection with L.S.U. Avenue; thence to the northeast along the center line of L.S.U. Avenue until it meets Stanford Avenue and continuing along the center line of Stanford Avenue until it meets University Lake; thence in a generally northerly direction along the east shore of University Lake until it meets a line drawn from Christian Street; thence to the northeast along the center line of Christian Street until its intersection with Perkins Road; thence to the north on the center line of Perkins Road until its intersection with Reymond Avenue; thence to the east on the center line of Reymond Avenue until its intersection with Eugene Street; thence to the north on the center line of Eugene Street until its intersection with Hundred Oaks Avenue; thence to the east on the center line of Hundred Oaks Avenue until its intersection with Glenmore Avenue; thence to the south along the center of Glenmore Avenue until its intersection with Woodside Drive; thence to the east on the center line of Woodside Drive until its intersection with Country Club Drive; thence to the north on the center line of Country Club Drive until it intersects a line drawn to the east as a continuation of Hundred Oaks Avenue; thence to the east along this line until it intersects College Drive; thence to the northeast along the center of College Drive until it intersects Wards Creek; thence in a generally southerly direction along Wards Creek until it intersects Essen Lane; thence to the southwest along the center of Essen Lane until it intersects Dawson Creek; thence to the northwest along Dawson Creek until it intersects Bayou Duplantier and continuing to the northwest along Bayou Duplantier until it meets a line which runs to the southwest between Nelson Avenue and Woodstone Avenue; southwest along this line until it meets Bayou Fountain at Ryan Drive; *thence to the west to the northern intersection of Ben Hur Road with Nicholson Drive; then to the southwest along the center line of Nicholson Drive to its intersection with the southern portion of Ben Hur Road; then to the south along the center line of Ben Hur Road until a point formed by an extension of the section line which forms the boundary between Sections 40 and 41, Township 8 South, Range 1 West; thence to the northeast along the entire southern boundary of Section 40, until its southwest corner; thence north along the section line forming the boundary between Sections 40 and 45 to the point of intersection with the northern boundary of Section 45; thence to the northwest along that line common to Sections 44 and 45 to its intersection with a point on the Mississippi River and the East Baton Rouge-West Baton Rouge civil parish line; thence to the north along the center line of the Mississippi River and the East Baton Rouge-West Baton Rouge civil parish line to a point drawn west from the intersection of Brightside Drive and River Road, the point of origin.*
